#### **QUALIFICATIONS:**

The candidate must be a Connecticut Registered Sanitarian with five or more years of experience and at least two years in a supervisory/leadership role. The ideal candidate must be certified in CT food service inspection, phase I and II subsurface sewage disposal systems, and lead certification. Must have a BA/BS in public or environmental health or a related field. The ideal candidate should be goal-driven, successful in time management, able to communicate well and problem-solve with the public and team members, have excellent computer skills, and work safely and independently.

#### **RESPONSIBILITIES:**

The Chief Registered Sanitarian will supervise the environmental health division. The successful candidate will plan, direct, and mentor environmental staff. Responsibilities include coordinating assignments, reviewing plans, and ensuring all staff are well-trained to provide guidance and support to the contractors, community members, and business partners we serve. This position requires strong administrative skills along with experienced field knowledge. The successful candidate must possess an interest in being a dedicated team leader and supporting the health district's values and mission.
